**NOTICE! PURSUANT TO EDCR 5.517, THIS INJUNCTION IS EFFECTIVE UPON THE PARTY REQUESTING SAME WHEN ISSUED AND AGAINST THE OTHER PARTY WHEN SERVED. IT SHALL REMAIN IN EFFECT FROM THE TIME OF ITS ISSUANCE UNTIL TRIAL OR UNTIL DISSOLVED OR MODIFIED BY THE COURT, AND CONSTITUTES A COURT ORDER ENFORCEABLE BY ALL REMEDIES PROVIDED BY LAW, INCLUDING CONTEMPT.**

**TO: Plaintiff and Defendant:  
YOU ARE HEREBY PROHIBITED AND RESTRAINED FROM:**

1. Transferring, encumbering, concealing, selling or otherwise disposing of any of the joint, common or community property of the parties or any property which is the subject of a claim of community interest, except in the usual course of conduct or for the necessities of life or for retention of counsel for the case in which the JPI is obtained; or cashing, borrowing against, canceling, transferring, disposing of, or changing the beneficiaries of:
  - (a) any retirement benefits or pension plan held for the benefit (or election for benefit) of the parties or any minor child; or
  - (b) any insurance coverage, including life, health, automobile, and disability coverage;

without the written consent of the parties or the permission of the court.
  
2. Molesting, harassing, stalking, disturbing the peace of or committing an assault or battery on the person of the other party, or any child, step-child, other relative, or family pet of the parties.

3. Relocating any child of the parties under the jurisdiction of the State of Nevada from the State without the prior written consent of all parties with custodial rights or the permission of the court.
